Proposed projects must meet both of the requirements below or will be designated as not eligible for funding:

- 1. At least 70% of the total CDBG request must benefit low and moderateincome families / households directly. Eligible income of beneficiaries must be documented either on an individual or an area wide basis. A project that is located in, or provides service to a HUD-defined low and moderateincome area that benefits a neighborhood generally is considered meeting the low & moderate income requirement. A location map and income limits are attached.
- 2. **Projects must be consistent with, and further one of the goals of the Five Year Consolidated Plan.** A Summary is attached. The entire 2005-2010 Consolidated Plan is available at the Planning Department at City Hall, 145 Taunton Avenue, Room 309.

All proposals must be submitted on the 2007-2008 Application for Funding form preferably in an electronic medium such as e-mail, no later than the **Application Deadline of March 19, 2007**. PROGRAM INFORMATION

The Community Development Act's Objectives:

The development of viable urban communities, including decent housing and suitable living environment, and expanding economic opportunity, principally for persons of low and moderate income

Basic Eligible Activities:

- a. **Acquisition:** Acquisition by purchase, long-term lease, donation or otherwise, in whole or in part, of real property for any public purpose.
- b. **Public Facilities and Improvements:** Acquisition, construction, rehabilitation or installation of public facilities and improvements carried out by the City or other public or private, non-profit entities.

Example: Shelters for the homeless, water and sewer facilities, flood and drainage improvements, fire protection facilities/equipment, community, senior and health centers, parking, streets, curbs, sidewalks, parks and playgrounds.

- c. **Clearance Activities:** Clearance, demolition, removal of buildings and improvements, including movement of structures to other sites.
- d. **Public Services:** Directed towards improving the community's public services and facilities, including those concerned with employment, crime prevention, child care, health, drug abuse counseling and treatment, education, energy conservation, welfare or recreational needs, job training, public safety services, and senior services.
- e. **Removal of Architectural Barriers:** Special projects to remove material and architectural barriers restricting the mobility and accessibility of elderly or disabled persons to publicly owned and privately owned buildings, facilities and improvements.

Example: Ramps, curb cuts, wider doorways, elevators.

f. **Rehabilitation Activities:** Finance the rehabilitation of any publicly or privately owned property.

Types of assistance:

- a. Assistance to private individuals and entities, including profit and non-profit organizations, to acquire for purpose of rehabilitation and to rehabilitate properties for use or resale for residential properties;
- b. Improvements, renovations or repair; replacement of principal fixtures and components; increasing efficient use of energy such as installation of storm windows and doors, siding, insulation and heating and cooling equipment;
- c. Rehabilitation services such as rehab counseling, tool bank, energy auditing, preparation of work specifications;
- g. **Planning and Capacity Building:** Studies, analyses, data gathering and preparation of plan.

Example: Individual project plans, community development plans, small area and neighborhood plans, environmental and historic preservation studies.

Community Development Consolidated Plan Summary Strategic Plan Goals 2005 - 2010

All CDBG funded programs must be consistent with, and contributing to the achievement of the following goals in order to be considered for funding.

HOUSING STRATEGIC PLAN

Goal One: Ensure that a diversity of housing exists in the City providing residents with a range of decent, safe and affordable housing choices.

Goal Two: Maintain and preserve the existing housing stock, including subsidized developments subject to prepayment.

Goal Three: Increase the supply of affordable housing for the various household income groups in the City.

Goal Four: Preserve the quality of existing residential neighborhoods while accommodating growth.

Goal Five: Increase the level of homeownership in the City.

Goal Six: Ensure a balance between housing development and the environment, including open space, recreational and economic development opportunities.

COMMUNITY DEVELOPMENT STRATEGIC PLAN

The City's housing strategic plan is developed by reference to existing planning documents that are official City policy and reflect current needs. The City will direct the use of the Community Development Block Grants towards activities that meet federal purposes and are consistent with the policy documents. The following identifies the objectives that address the highest priority needs in the identified categories:

Public Facilities/Public Infrastructure Needs

GOAL ONE: Continue to identify and prioritize public infrastructure needs in eligible neighborhood areas, such as upgrading or replacing sewer lines, road and sidewalk reconstruction.

GOAL TWO: Continue to identify and prioritize revitalization needs of public facilities, such as parks and playgrounds, recreational sites and other eligible public properties.

Public Service Needs

GOAL ONE: Continue to meet the financial, social and environmental needs of the senior population.

GOAL TWO: Provide programs for youth which allow them to reach their full potential and guide them toward appropriate social and recreational opportunities.

GOAL THREE: Continue to support quality, accessible and affordable medical services for all eligible residents.

GOAL FOUR: Continue to provide job training programs and re-training programs which graduate residents with usable skills in fields with employment opportunities.

GOAL FIVE: Continue to provide educational opportunities and appropriate social services to families in need of assistance in order to improve their economic or social circumstances.

Economic Development Needs

GOAL ONE: Continue to support and create programs that facilitate the rehabilitation of commercial businesses in eligible areas.

GOAL TWO: Continue to support and create programs that provide job training for unemployed, underemployed or unskilled persons.

2007 – 2008 CDBG APPLICATION RANKING

The categories of Housing, Public Services, Public Works, Public Facilities, and Economic Development below will be ranked separately. Each category is allocated a percent of the total CDBG annual award of \$800,000 based on the priorities of the Five Year Consolidated Plan (2005-2010). The top ranked proposals in each category will be included in a draft One Year Action Plan and made available for public comment for 30 days starting with a Public Hearing on April 10, 2007 at City Hall, room 306 at 6:00 p.m., and ending on May 10, 2007 at 4:00 p.m. Once all comments have been considered and responded to, final recommendations will be made to the City Manager and Council for funding. The approved Action Plan will then be submitted to HUD by May 11, 2007. Programming is expected to start by July 1, 2007 and end by June 30, 2008.

May 1, 2007

Submit plan for use of funds to HUD for approval within 46 days.
