DO YOU QUALIFY FOR EAST PROVIDENCE'S PROPERTY TAX EXEMPTIONS?

- 1. HOMESTEAD EXEMPTION 13% OFF YOUR PROPERTY TAX BILL FOR OWNER OCCUPIED 1-3 FAMILY RESIDENTIAL PROPERTIES (INCLUDING CONDOS). DUE DATE MARCH 15TH.
- 2. OVER 65 EXEMPTION \$574.46 OFF THE PROPERTY TAX BILL FOR HOMEOWNERS WHO ARE OVER 65 YEARS OLD (ONLY ONE OVER 65 EXEMPTION PER HOUSEHOLD & MUST BE OWNER OCCUPIED) <u>DUE DATE MARCH 15TH</u>.
- 3. VETERANS/WIDOW OF VETERAN EXEMPTION—\$169.87 OFF THE PROPERTY TAX BILL—CERTAIN REQUIREMENTS MUST BE MET, PLEASE CONTACT THE OFFICE FOR DETAILS. <u>DUE</u> DATE MAY 25TH.
- **4. TOTAL SERVICE-CONNECTED DISABLE VETS** \$338.91 OFF THE PROPERTY TAX BILL MUST BE 100% DISABLED, NOT COLLECTING 100%. **DUE DATE MAY 25**TH.
- 5. GOLD STAR PARENT EXEMPTION \$257.38 OFF THE PROPERTY TAX BILL FOR PARENTS OF VETERANS DECEASED DURING COMBAT. DUE DATE MAY 25TH.
- 6. VETERAN'S MODIFIED HOUSING \$338.91 OFF THE PROPERTY TAX BILL. PLEASE CONTACT THE OFFICE FOR DETAILS. <u>DUE DATE MAY 25TH.</u>
- 7. CERTIFIED 100% BLIND EXEMPTION- \$609.46 OFF THE PROPERTY TAX BILL LETTER FROM THE DEPARTMENT OF HUMAN SERVICES FOR THE BLIND & VISUALLY IMPAIRED IS REQUIRED. DUE DATE MARCH 15TH.
- 8. HARDSHIP EXEMPTION VARIABLE AMOUNT OFF THE PROPERTY TAX BILL, PLEASE SEE THE OFFICE FOR MORE DETAILS. <u>APPLICATIONS ONLY OFFERED FROM JANUARY 1^{ST} -APRIL 15^{TH} . DUE DATE APRIL 15^{TH} .</u>
